

#### VI. OLD BUSINESS

Mr. Schweiger explained the items listed in the agenda (W-9 forms, percent ownership form, appraisal release form, good faith payment, offer letter, plot, appraisal and conservation plan) are all completed. The title search is currently in the process of being completed because of the update of the parcel being added to the Cumberland Township ASA.

#### **VII. NEW BUSINESS**

1. Dominick and Kimberly Barbetta #1 (79.175 ac.) – LESA score: 50.97 Mr. Schwiger explained that previously at the January boar meeting the discussion occurred that Douglas Wolfgang from the Department of Agriculture stated the title was considered acceptable by the state and the district can move forward if they so choose. It was unclear at that time whether or not the farm would need reranked. Mr. Wolfgang stated the farm does not need to be reranked and the district can move forward with the current ranking.

A motion was made by Charles Day to move forward with the farm encumberment. Chris Eisiminger seconded. (motion passed)

2. William A. Cree, Jr. and Lura Ann Cree #3 (83.029 ac.) – LESA Score: 59.47 Mr. Schweiger explained how the state granted an extension under the circumstances of the updates required for the title search based on the addition of the parcel. The title search update can be made once the parcel is recorded by Cumberland Township. There was a misunderstanding that the township would require a meeting however the scheduled meeting was delayed, but then it was understood an update would only be needed. Mr. Hook and Cumberland Township are actively working on this and will be processed soon. The farm encumberment is still planned to meet the states April board meeting.

### 3. Phillips Farm

Mr. Schweiger explained one of the farmers in the program, Mr. Phillips had passed away. Mr. Schweiger and Ms. Hlatky will be scheduling a meeting with Mrs. Phillips to discuss the status of the farm and if any changes will need to be made based on management. It is the understanding there are employees managing the farm currently and there should not be an issue in correlation to the program requirements. However, a meeting will be made with Mrs. Phillips to go over the requirements of the program and discuss any changes.

#### VIII. OUTREACH

Ms. Snider stated the public will be notified the district is currently accepting applications for Farmland Preservation. This notice will be added to the district's newsletter and will be put into local newspapers. The application period will be over at the end of April, if there are no applications received the application period will be extended another 90-days.
