# **MOTIONS**

1. Commissioner Betsy McClure made the motion and Commissioner Blair Zimmerman the second to approve the minutes from the January 21, 2021 Prison Board meeting. Vote unanimous.

### **SECURITY**

- 1. There was one (1) reportable Extraordinary Occurrence Report (EOR) submitted to the Pennsylvania Department of Corrections for the Month of January 2021.
- 2. The facility issued eight (8) major misconducts and nine (9) minor misconducts for the month of January 2021.

#### **TREATMENT**

1. The CIDVID remote visitation system has been installed allowing scheduled video visitation and text messaging between Inmates and friends and family. The startup date for usage will be 022221 following the revision and reissuance of Policy # 21 Visitation and Volunteers and Policy # 42 Mail Privileges.

- 2. We have submitted for and received the funding from Encartele for required video equipment to be utilized in the Conference Room, allowing not only scheduled video Court Hearings, but also remote Adult Basic Education, Programming, Ministries, and other Volunteer programs.
- 3. Inmate Haircuts were conducted on 021721.

#### STAFFING AND TRAINING

1. We are currently interviewing applicants for the position of Food Service Worker due to the resignation of Andrea Orlandi.

### **MAINTENANCE**

1. Mr. Ziefel and County Maintenance have completed the construction of the wall and security door in the former visiting room. This security barrier has allowed the usage of the enclosed area for records storage and an additional secured area for the placement of emergency response equipment. The area formally used as non- contact visitation is being converted to two (2) separate security holding cells for temporary detainees.

#### **FINANCIAL REPORT**

- 1. The January assessed revenue report generated from the Greene County Central Booking Center was \$6,650.00 with \$1,681.67 being an actual paid return for the month.
- 2. We have deposited \$585.00 for Work Release Inmates in January 2021.
- 3. Fayette County paid \$500.00 in rental fees for the month of December 2020 and \$1,100.00 for the month of January 2021.
