MOTIONS

1. Commissioner Betsy McClure made the motion and Controller Ami Cree the second to approve the minutes from the May 2023 Prison Board meeting.

SECURITY

- 1. There were Five (5) reportable Extraordinary Occurrence Reports (EOR) submitted to the Pennsylvania Department of Corrections for the Month of May 2023
- 2. The facility issued Twenty-one (21) major misconducts and Twenty-five (25) minor misconducts for the month of May 2023.
- 3. The average daily population for May was Seventy-One (71) with Sixty-Seven (67) being the lowest number and Seventy-Seven (77) being the highest

TREATMENT

1. During the month of May, Landmark Baptist Church conducted Two (2) men's bible study groups. Road to Recovery conducted Three (3) men's bible study groups. First Assembly Church conducted Four (4)

women's bible study groups, Gospel Gang visited on Two (2) occasions and WWJD Christian Center visited on Two (2) occasions in May.
