CALL TO ORDER:

- 1. Sandy Wilson called the meeting to order at 3:32 p.m.
- 2. Blair Zimmerman made the motion and Dan Bazzoli seconded to approve the October 11, 2023 meeting minutes. Vote was unanimous.

ACCOUNTS RECEIVABLE

1. JoAnne Marshall reported the ending balances as of October 31, 2023 were: Hotel/Motel Tax at \$383,940.01 and TPA Fundraising at \$33,312.30.

1. Blair Zimmerman made the motion and Dan Bazzoli seconded to approve the November 8, 2023 Disbursement Request (Attachment 1) totaling \$18,356.97. Vote was unanimous.

DIRECTOR REPORT

JoAnne Marshall shared that PRLA and Pennsylvania tourism offices are in favor of new legislation
around Tourism Improvement Districts (TID). The legislation would permit an additional tax on
hotel room rentals in a specified area with the board consisting of the hotel operators. They would
work together to decide how to use the additional revenue. While it is a good idea for many areas
across the state and possible for us in the future, it would not work at this time in Greene County.

- 1. Blair Zimmerman made the motion and Bethany Tanner seconded to continue the WANB and WKVE Tourism Minute spots year-round at \$140 per week. Vote was unanimous.
- 2. The board declines to participate in VisitPITTSBURGH's 2024 Insider Guide.
- 3. Courtney Hursey made the motion and Bethany Tanner seconded to participate in Anderson's Brochure Distribution Service of 24 shows in 2024 for \$4,250. Vote was unanimous.
- 4. Bethany Tanner made the motion and Dan Bazzoli seconded to re-print the Greene County Map brochure. Vote was unanimous.
- 5. The board declines to participate in VisitPA's Winter Co-Op advertising.
- 6. JoAnne Marshall shared the possibility to advertise with Forever Media Group and WTAJ. Further discussion and research is requested as we move into Spring/Summer 2024.
- 7. JoAnne Marshall shared about the location intelligence and foot traffic data software opportunity from Placer.ai. The board would like to investigate the software further including a presentation from Placer.ai.

8. JoAnne Marshall shared the October 2023 Advertising Summary that featured print in Pennsylvania Business Central and GoXplore, WANB and WKVE radio ads, and digital reach through VisitGreene platforms which includes 7,170 users on the website, 329,575 users on Facebook, and 48,392 users on Instagram.
