Effective August 8, 2014; Act 113 & 236 of 2014

ROD cannot give change when paying by check.

All fees include up to four (4) pages and four (4) names per document.

Additional pages are \$2.00 each. Additional names are \$0.50.

Notary stamp must be legible for reproduction.

Exhibit font size must be no smaller than 12pts.

Stamped return envelope required.

Three (3) checks (recording fee, 1% state tax, 1% local tax) required when recording documents with transfer taxes.
