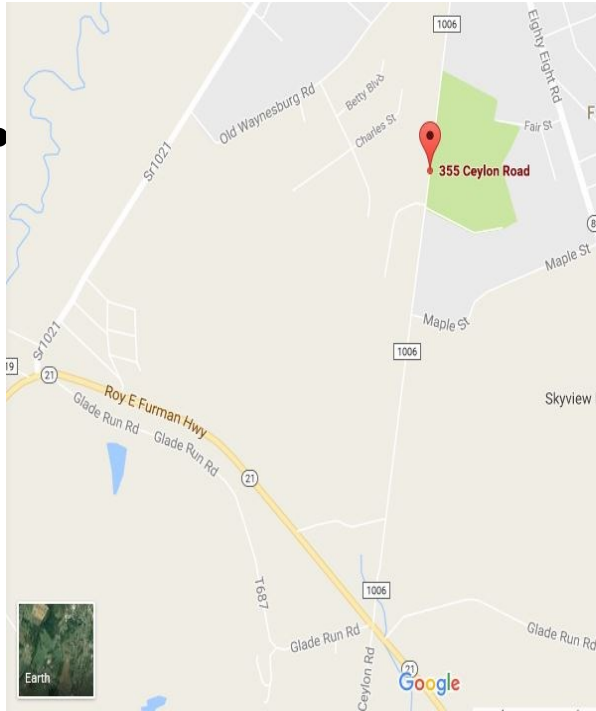

Casseday (whom in April 2016 was named one of Greene County's most influential people for his foundation efforts to help families affected by autism by the Greene County Messenger) after his son's autism diagnosis, Damon identified gaps in services available for children and families living in and around the Greene County area. Since then, the foundation has grown to include a Board of Directors comprised of parents of autistic children, physicians, healthcare professionals, autism therapists and community volunteers.

In April 2016, the foundation was recognized by the Greene County Board of Commissioners during Autism Awareness Month for its efforts and mission to help support families and individuals living with autism in the Greene County area. The foundation continues in its mission to assist and support those families affected by autism through fundraising, support group meetings and community partnerships.
